4.1 Council Consideration and Adoption of Resolution No. 36-22 Approving and Employment Agreement with William Steven Wong for Position of Finance Director (Jim Goodwin, City Manager)

#### Staff recommendation:

Staff recommends that the Wheatland City Council provide direction to staff to prepare an ordinance to amend the Wheatland Municipal Code in order to expedite electric vehicle charging stations (EVCS) in compliance with Assembly Bill (AB) 1236 and AB 970, as well as a general plan amendment including language in the City's Safety Element regarding the local hazard mitigation plan (LHMP) in compliance with Assembly Bill (AB) 2140.

4.3 Council discussion and Consideration of an Agreement with ClearSource Financial Consulting for preparation of a water and sewer rate analysis (Jim Goodwin, City Manager)

#### Staff recommendation:

Staff recommends approving the agreement with ClearSource Financial Consulting for preparation of a water and sewer rate analysis at an amount not to exceed \$45,900 and direct the City Manager to sign.
