 Agreement concerning Jones Ranch between the City of Wheatland and Dale Investments, LLC.
 The approved Third Amended and Restated City of Wheatland Development Agreement Concerning Jones Ranch Subdivision has been amended to extend the term of the existing Development Agreement.
