# CITY COUNCIL MEETING STAFF REPORT

Consideration and Adoption of Resolution Authoring Execution of Agreement for Banking Services with Five Star Bank

#### Recommendation

Staff recommends that the Wheatland City Council consider adoption of a resolution authorizing the Finance Director to execute an agreement for banking services with Five Star Bank.

#### Background

The City has utilized Umpqua Bank to provide its banking services for many years – going back at least as far as 2005. It is staff's understanding that Umpqua Bank was selected because, at the time, Umpqua Bank maintained a branch office in Wheatland. That brank office has since been closed.

### Discussion

Due to staff's concern over the level of banking services provided and increased banking costs, a Request for Proposal for banking services was issued. Proposals were received from three banks – Five Star bank, Tri-Counties Bank and JP Morgan Chase Bank. The proposals were evaluated based upon services provided and cost. Based upon that review, staff is recommending that Five Star Bank be selected to provide the City's banking Services.

Five Star Bank will provide all of the services currently provided by Umpqua Bank and in addition has offered a cash-pick-up courier service at no charge which will eliminate the staff's current practice of traveling to Lincoln or Marysville to make cash deposits. Five Star Bank offers an earnings credit rate of 2.0 percent on funds in the City's checking accounts which will cover the cost of baking services. (Recent monthly charges from Umpqua Bank were in the range of \$450 to \$500). In addition, Five Star Bank offers the ability to sweep excess funds into a money market account which is currently providing an earnings rate of 3.75 percent. Five Star Bank has its headquarters in Roseville with a local branch in Yuba City.

# **Fiscal Impact**

Approval of this item will result in annual General Fund savings of approximately \$5,000.

## Conclusion

Based on the information contained in the staff report, staff recommends that the Wheatland City Council adopt the resolution authorizing the Finance Director to execute an agreement for banking services with Five Star Bank.

# RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WHEATLAND AUTHORIZING EXECUTION OF AGREEMENT FOR BANKING SERVICES WITH FIVE STAR BANK

**WHEREAS**, the City has utilized Umpqua Bank as it's banking services provider for many years; and

WHEREAS, it is good practice for public agencies to periodically solicit banking services competitively in order to stay updated with state of the art banking technologies and to take advantage of competitive pricing; and

**WHEREAS,** a Request for Proposal for Banking Services was issued by the Finance Department, with three proposals received; and

**WHEREAS**, after a review of the proposals received, it was determined that Five Star Bank offered the highest level of service and most favorable pricing.

### CITY OF WHEATLAND AND FIVE STAR BANK BANKING SERVICES AGREEMENT

THIS AGREEMENT is entered into on August 23, 2023, by and between the City of Wheatland, a general law city ("City"), and Five Star Bank (Bank), who agree as follows:

- 1. Services to be provided. Bank shall render the services described in the attached June 19, 2023 letter proposal to provide services and the June 19, 2023, 4:57pm email providing a free check scanner to make deposits and the June 21, 2023, 11:19am email providing bank courier deposit pick up services free of charge.
- 2. Fees. Fees to be charged will be the Bank's standard fees and charges as set forth in the Commercial Fee Schedule offset with a 2.00% earnings credit rate, as described in the Analyzed checking accounts with a 2.00% Earnings Credit Rate paragraph in the June 19, 2023 letter.
- 3. Term. This Agreement may be terminated at any time by City. In the event of such termination, Bank shall be fairly compensated for all fees earned to the date of termination as calculated by City based on the above fee provisions. Compensation under this subsection shall not include any termination-related expenses, cancellation or demobilization charges, or lost profit.
- 4. Compliance with Laws. Bank shall continue in compliance with all applicable federal, state and local laws and regulations. Bank shall possess, maintain and comply with all federal, state and local permits, licenses and certificates that may be required for it to perform banking services.
- 5. Indemnification. Bank shall, to the fullest extent permitted by law, indemnify, defend (with counsel approved by City), protect, and hold harmless City, and its officers, employees, volunteers and agents from and against any and all liability, losses, claims, damages, expenses, demands, and costs (including, but not limited to, attorney, expert witness and consultant fees, and litigation costs) of every nature arising out of Bank's performance of services and caused by any negligent act or omission, willful misconduct or violation of law of or by Bank or its employees, agents and subcontractors, except where caused by the sole negligence or willful misconduct of City or as otherwise provided or limited by law. Bank's obligations under this indemnification provision shall survive the termination of, or completion of services under this Agreement.
- **6. Entire Agreement; Amendment.** The parties intend this writing to be the sole, final, complete, exclusive and integrated expression and statement of the terms of their contract concerning the Work. This Agreement supersedes all prior oral or written negotiations, representations, contracts or other documents that may be related to the Work, except those other documents (if any) that are expressly referenced in this Agreement. This Agreement may be amended only by a subsequent written contract approved and executed by both parties.
- 7. Assignment. Bank may not assign, delegate, transfer or subcontract any of its rights, duties, obligations or other interests in this Agreement without City's prior written consent.

Any assignment, delegation, transfer or subcontract in violation of this provision is null and void.

- 8. No Waiver of Rights. Any waiver at any time by either party of its rights as to a breach or default of this Agreement shall not be deemed to be a waiver as to any other breach or default. No payment by City to Bank shall be considered or construed to be an approval or acceptance of any services or a waiver of any breach or default.
- **9. Severability.** If any part of this Agreement is held to be void, invalid, illegal or unenforceable, then the remaining parts will continue in full force and effect and be fully binding, provided that each party still receives the benefits of this Agreement.
- 10. Governing Law and Venue. This Agreement will be governed by and construed in accordance with the laws of the State of California. The county and federal City court where City's office is located shall be venue for any state and federal court litigation concerning the enforcement or construction of this Agreement.
- 11. Notice. Any notice, invoice or other communication that is required or permitted to be given under this Agreement shall be in writing and either served personally or sent by prepaid, first class U.S. mail addressed as follows:
