FIRST AMENDMENT TO AGREEMENT BETWEEN THE CITY OF WHEATLAND AND DON SCOTT FOR PUBLIC WORKS DIRECTOR SERVICES

THIS FIRST AMENDMENT TO THE PUBLIC WORKS DIRECTOR SERVICES AGREEMENT (AMENDMENT) is made and entered into effective January 14, 2020, by and between the CITY OF WHEATLAND (CITY) and DON SCOTT (SCOTT), and is based on the Recitals and matters set forth herein.

RECITALS

- A. **SCOTT** serves as **CITY's** Public Works Director pursuant to an Agreement dated July 1, 2019 (the "**ORIGINAL AGREEMENT**").
- B. In consideration of the good and valuable services **SCOTT** has been performing for **CITY** under the **AGREEMENT**, and **CITY**'s desire to retain **SCOTT** to continue to perform those services, the **PARTIES** desire to amend the **ORIGINAL AGREEMENT** to include the additional provisions stated below.
- C. Collectively, the **ORIGINAL AGREEMENT** and this **AMENDMENT** will be referred to hereafter as the "**AGREEMENT**" and will constitute the entire understanding and agreement of the **PARTIES**.

IN CONSIDERATION of the mutual covenants contained herein and for good and valuable consideration, the **PARTIES** agree as follows:

SECTION 1 Amendment to Paragraph 2

The **ORIGINAL AGREEMENT** is hereby amended to read as follows:

2. **Term.** This Agreement shall remain in effect until June 30, 2020 unless sooner terminated as provided by the termination provision below.

Except as specifically modified by the terms of this **AMENDMENT**, the provisions of the **ORIGINAL AGREEMENT** are unchanged and remain in full force and effect.
