Recommendation

Staff recommends adopting Resolution No. 16-22 approving the Amendment No. 1 to the Employment Agreement as presented.

Background/Discussion

Dale Klever was appointed Public Works Director, and an employment agreement approved by the City Council, in May of 2020. The agreement was for two years effective June 1, 2020, and terminating May 31, 2022, if not extended by action of the City Council.

The amendment before you will extend Mr. Klever's contract for 5 years, with the agreement terminating on May 31, 2027. Under the terms of the original agreement, unchanged by this amendment, Mr. Klever may be terminated without cause at any time with 30 days written notice.

Alternatives

The City Council may choose not to approve the proposed Amendment No. 1 to the Employment Agreement.

Fiscal Impact

No impact as the position is funded in the current budget.

FIRST AMENDMENT TO AGREEMENT BETWEEN THE CITY OF WHEATLAND AND DALE KLEVER FOR PUBLIC WORKS DIRECTOR SERVICES

THIS FIRST AMENDMENT TO AGREEMENT BETWEEN THE CITY OF WHEATLAND AND DALE KLEVER FOR PUBLIC WORKS DIRECTOR SERVICES is made and entered into effective May 24, 2022 by and between the CITY OF WHEATLAND (CITY), a municipal corporation, and DALE KLEVER (EMPLOYEE), an individual, and is based on the Recitals and matters set forth herein.

RECITALS

- A. EMPLOYEE serves as CITY's Public Works Director pursuant to the AGREEMENT BETWEEN THE CITY OF WHEATLAND AND DALE KLEVER FOR PUBLIC WORKS DIRECTOR SERVICES dated May 12, 2020 (the "AGREEMENT").
- B. Following negotiations between the EMPLOYEE and CITY, and in consideration of the good and valuable services EMPLOYEE has been performing for CITY under the AGREEMENT, and CITY's desire to retain EMPLOYEE to continue to perform those services, the PARTIES desire to amend the AGREEMENT to include the additional provisions stated below.
- C. Collectively, the **AGREEMENT** and this **AMENDMENT** will be referred to hereafter as the "**AGREEMENT**" and will constitute the entire understanding and agreement of the **PARTIES**.

IN CONSIDERATION of the mutual covenants contained herein and for good and valuable consideration, the **PARTIES** agree as follows:

SECTION 1 Modification of Paragraph 2

Paragraph 2 of the **AGREEMENT** is amended to read as follows:

Term. This Agreement shall remain in effect through May 31, 2027, unless sooner terminated as provided by the termination provision below.

Except as specifically modified by the terms of this **AMENDMENT**, the provisions of the **AGREEMENT** are unchanged and remain in full force and effect.

IN WITNESS WHEREOF, the parties have executed this **AMENDMENT** with an effective date as set forth above.
