SUBJECT: Consideration and Adoption of Resolution Authorizing the Purchase of a Replacement Public Works Vehicle from Folsom Lake Ford

Recommendation

Staff recommends that the Wheatland City Council consider adoption of a resolution authorizing the purchase of a replacement vehicle from Folsom Lake Ford for use by the Public Works Department staff.

Discussion

The City's Public Works Department staff utilize City vehicles on a daily basis to complete their assigned tasks of streets, parks and facilities maintenance. During the development of the Fiscal Year 2024-25 budget, a Vehicle and Equipment Replacement Fund was established to accumulate funds for the orderly replacement of the City's aging vehicle fleet and equipment inventory. The Fiscal Year 2024-25 adopted budget includes \$40,000 in the Vehicle and Equipment Replacement fund for the replacement of a 2007 Chevrolet pickup truck that has exceeded its useful life. The replaced vehicle will be sold at public auction with any funds received deposited to the Vehicle and Equipment Replacement Fund.

The recommended purchase is a 2024 Ford Ranger pickup truck from Folsom Lake Ford that is being purchased under a government fleet purchase contract. The total purchase price is \$_____.

Fiscal Impact

Funding for this purchase is available in the Fiscal Year 2024-25 Vehicle and Equipment Replacement Fund budget.

WHEREAS, the City received a quotation for the purchase of a 2024 Ford Ranger pickup truck from Folsom Lake Ford under the provisions of a cooperative government purchase agreement; and
