I am writing to advise you that Mr. Justin Guzman, your representative on the Board of Trustees of the Sutter-Yuba Mosquito & Vector Control District, has informed me of his resignation from the Board, effective July 12, 2024. The California Health and Safety Code addresses filling vacancies on Boards of Trustees. As provided under Division 3, Chapter 1, Article 3, Section 2024(b), the term of the appointment of a new Board member to this vacant seat shall fill the balance of the unexpired term, ending December 31, 2026. Section 2022(b), stipulates that the appointee must be a voter and a resident of the City of Wheatland.

Please accept my letter of interest in serving on the Sutter-Yuba Mosquito & Vector Control District Board of Trustees as Wheatland representative. The seat vacated by Trustee, Justin Guzman became open after his last meeting on July 11, 2024, where he officially announced his resignation. The California Health & Safety Code division 3, chapter 1, article 3, section 2022(b) stipulates that each person appointed to a mosquito agency board, be a voter and resident of the city. Furthermore, section 2024(b) requires an appointment to fill a vacancy, on an agency board of trustees be for the balance of the unexpired term, instead of for a full, four-year term.
