## Discussion and consideration of the following items:

- Consideration to recommend City Council approval of Amendment No. 1 to City of Wheatland Tier

  1 Development Agreements Concerning the Johnson Rancho Project. Section 3.1 (Developer Funding of Planning Documents) and 4.3 (Annexation Fee) of the approved City of Wheatland Development Agreements Concerning Johnson Rancho are proposed to be amended to be consistent with changes that have occurred after the Development Agreements were executed.
- Consideration to recommend City Council adoption of an ordinance amending the zoning code to ban all outdoor cultivation of marijuana, for both medical and personal use, and to prohibit all commercial marijuana activities within the City of Wheatland. The proposed ordinance would amend the City's zoning code to extend the City's existing ban on the outdoor cultivation of medical marijuana so that it also applies to marijuana grown for personal use by adults. The proposed ordinance would also amend the City's zoning code to prohibit land uses for commercial marijuana activities within Wheatland.

Information on the proposed discussion items is available for review at Wheatland City Hall, located at 111 C Street, Monday through Friday from 8:00 a.m. to 12:00 p.m. and 1:00 p.m. to 5:00 p.m.

All Interested Persons are invited to attend the public hearing and present written and/or oral comments on the approval associated with the proposed development agreement amendment. If you challenge the approval of the proposed project in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice or in written correspondence delivered to the City at or prior to the public hearing (Government Code Section 65009).
