State Law Requirements for Businesses, Organizations & Multi-Family Dwellings



AB 1826 MANDATORY COMMERCIAL ORGANICS RECYCLING

Effective January 1, 2021, California Assembly Bill 1826 requires businesses and organizations that generate two (2) or more cubic yards of waste per week to recycle organic waste. Organic wastes include food waste, food soiled paper, garden and landscape waste, and clean/untreated wood. Businesses and organizations can subscribe to Recology Yuba-Sutter's organics composting program or make their own arrangements for recycling organic wastes.

Multi-family dwellings with five (5) or more dwelling units and shared refuse service are also subject to AB 1826, but are not required to recycle food waste, only yard waste and landscape materials generated at their properties. However, if you would like to start recycling food waste, we can help.

AB 341 MANDATORY COMMERCIAL AND MULTI-FAMILY RECYCLING

Effective July 1, 2012, California Assembly Bill 341 requires businesses and organizations that dispose of four (4) or more cubic yards of commercial solid waste per week and multi-family dwellings with five (5) or more dwelling units and shared refuse service to recycle. Businesses, organizations and multi-family dwellings can subscribe to Recology Yuba-Sutter's recycling program or make their own recycling arrangements.


AB 827 PROVISION OF RECYCLING CONTAINERS FOR CUSTOMER USE

Effective July 1, 2020, California Assembly Bill 827 requires businesses, organizations and multi-family dwellings that are subject to AB 1826 and AB 341 to provide customers with solid waste recycling and/ or organics containers to collect material generated from products purchased on the premises. The containers must be visible and easily accessible to customers and clearly marked with labeling indicating which materials are appropriate for each container. The containers must be adjacent to each trash can (restroom waste bins are excluded). Full-service restaurants are exempted from providing containers for customers if containers are provided wherever trash containers are located for employees to recycle solid waste and organics.

PURPOSE OF THE LAWS:

- Reduce disposal in landfills
- Reduce greenhouse gas emissions

Two (2) cubic yards is equal to a rectangle 3 feet high, by 3 feet wide, by 6 feet long.



WHAT GOES IN THE **ORGANICS** BIN?

We accept food scraps, food soiled paper products, coffee grounds & filters, meat, bones, dairy, waxed cardboard, clean wood and yard waste.



COVERED BUSINESSES INCLUDE:

Office buildings, retail, restaurants, non-profits, strip malls, government offices and schools. Multi-family dwellings include apartments, townhomes and condominiums.

JURISDICTION RESPONSIBILITIES:

The local jurisdictions are required to inform potentially covered entities of these laws; available organic and recycling waste collection services; and, to monitor compliance with the laws.

WHAT GOES IN THE **RECYCLING** BIN?

We accept paper, cardboard, magazines, glass bottles & jars, metal cans, aluminum, small scrap metal and plastic containers numbered 1-7.
